

GDP: +1.6% (2023 estimate)

GDP nominal : per capita US\$64.9k - world rank 13<sup>th</sup> (2023 estimate)

Government Gross Debt : A\$897 billion (34.9% of GDP, May 2023) - A\$1,067 trillion (2023-2024 forecast)

8<sup>th</sup> total estimated value of world's natural resources

Cash rate: 4.1% (following continuous increases by RBA; highest in the last 11 years)

Inflation rate: ±7% (April 2023)

Unemployment rate: ± 3.5% (April 2023)



### <u>Australia – Economy</u> (business environment)

Business environment that is ranked 14<sup>th</sup> out of 190 economies for ease of doing business (2022) [Starting a business 7<sup>th</sup> | Getting credit 4<sup>th</sup> ]

Transparent and robust regulatory system

Stable institutional frameworks

Strong finance and banking regulations



### <u>Australia – Economy</u> (cost of living)

Estimates for average weekly ordinary time earnings for full-time adults Average weekly earnings A\$1,807.70 or ±€1.133 (annually to November 2022)

Consumer Price Index : +1.4% in the March 2023 quarter and 7% annually (Australian Bureau of Statistics). Cost of living: a single person estimated monthly costs are A\$1,602 without rent. Cost of living in Australia is, on average, 7.1% higher than in United States.

- ✓ Visit their premises


